2022 Project Summaries

City of Marquette

The City of Marquette planned for and began implementing the community engagement phase of the Community Master Plan update. Climate change adaptation and mitigation will have it's own section in the plan. The City of Marquette also began a resiliency planning process with the Michigan Economic Development Corporation (MEDC) and Smith Group. Representatives from Smith Group gave a presentation to CATF about the resiliency planning process and receive input from CATF members on the utilization of the existing NMU Coastlines and People and Marquette County Climate Plans.

Community Foundation of Marquette County (CFMC)

The Community Foundation's mission is to enrich the lives of all people in Marquette County by connecting donors with community needs, building permanent funds for charitable giving, distributing scholarships and grants, and leading and collaborating to address community opportunities. To further their mission in 2022, CFMC supported local nonprofits and programs with more than \$1.2 million in grants, including funding for education, the environment and human services. CFMC also distributed more than \$130,000 in scholarships from the 76 scholarship funds we administer to 64 college-bound graduating seniors throughout the county.

The creation of this interactive map is intended for municipalities to work together to make Marquette County more resilient and open new opportunities for funding. Marquette Charter Township is focused on updating its Zoning Ordinance throughout the winter to make it more friendly to higher capacity development (ADU's, multi-family homes, etc.) and streamlining the permitting process for residential solar which currently requires a special use permit and a public hearing.

Michigan State University Extension (MSUE)

Brad Neumann presented a webinar discussing green infrastructure for stormwater management in rural and suburban settings on Thursday, June 16th.

Brad invited local representatives to participate in the Michigan Renewable Energy Academy on planning for and regulating the development of renewable energy infrastructure. A workshop was held in Marquette County on May 16th.

Brad hosted the Citizen Planner Program in partnership with Marquette County and Marquette Charter Township.

Northern Michigan University (NMU)

In summary, sustainability gains made by NMU in recent years have been led by students. NMU's recently adopted Interim Strategic Plan places a greater responsibility on the institution to make structural changes and investments in sustainability. Some action items include developing an energy and carbon neutrality plan, transitioning the University's fleet to hybrid and electric vehicles, implementing a post-consumer composting program, and developing an interdisciplinary sustainability curriculum accessible to students from all degree programs.

NMU's Sustainability Hub for Innovation & Environment (SHINE) is now 75% powered by a solar array paid for by students through the Green Fund.

EcoReps is a student sustainability peer-to-peer education program designed to give students the resources and knowledge to solve environmental, economic and social sustainability issues. EcoReps participated in Sustainability Week, hosted skill builder workshops, supported campus, sustainability initiatives, and funded Green Fund projects aimed to make NMU a more sustainable campus. Project submissions ranged widely from student awareness programs and behavior-changing campaigns to infrastructure upgrades and installations.

Superior Watershed Partnership (SWP)

SWP partnered with the City of Marquette to resubmit a \$1.6 million grant application to the Department of Transportation. The grant was funded and publicly touted by the Secretary of Transportation Pete Buttigieg as an example of the importance of perseverance while encouraging other applicants whose first applications aren't funded to rework and resubmit their proposal. The sand dredged from the port will be repurposed for the renaturalization of the green space between Lakeshore Boulevard and the Lake Superior shoreline. Restoration efforts of Lakeshore Boulevard began this year with trees, shrubs, beach grass and other native

flora planted as the first step of a much larger naturalization project that will continue through next year.

SWP partnered with the City of Marquette to coordinate another salamander migration this year at Presque Isle Park. SWP and NMU's Biology Department incorporated a citizen science component to inform future road closure dates and times and provide local data for classroom exercises.

SWP received a \$216,000 GLRI grant to plant thousands of trees in Ishpeming, Hannahville Indian Community, and Keweenaw Bay Indian Community.

SWP hired, trained, and deployed more than 40 Great Lakes Climate Corps seasonal employees across the Upper Peninsula this summer to work alongside project partners on conservation, restoration, and recreation projects across the UP. Some highlights included initial plantings and recreation infrastructure installation along Lakeshore Boulevard, coastal restoration plantings with the Hiawatha National Forest, more than 100 miles of trail improvements in the Ottawa National Forest, and thousands of trees planted UP wide.

You can learn more about SWP's Stannard Rock Lighthouse & International Climate Research Station by visiting the Marquette Maritime Museum. A new sign was installed overlooking the lake describing the collaborative climate research happening 45 miles out in Lake Superior.

SWP has \$288,000 of funding available to remove hazardous fuel loads (tree and brush removal) around community infrastructure to reduce the impact and risk of wildfire. SWP is looking for partners to help identify fire mitigation/climate adaptation project locations in their community/jurisdiction.

SWP received a service award from Governor Whitmer and the Michigan Public Service Commission recognizing their contributions during the beginning of the pandemic including manning contract tracing phones, hosting food distribution events, and opening campgrounds and trails to allow people to recreate safely outdoors weeks before they would've been able to otherwise.

SWP is partnering with the DNR Forest to Faucet program to plant trees in the Dead River Basin in Marquette County. This project will result in thousands of trees planted in Marquette County for the benefit of drinking water quality.

SWP's MEAP office continued its charge to provide low-income Upper Peninsula residents with free emergency assistance to pay energy bills, financial literacy classes, energy efficiency upgrades, and solar unit installations. This program serves thousands of people each year by lowering their energy bills by improving home efficiency and reducing consumption of GHG emitting energy.
